

BREAST SURGICAL ONCOLOGY FELLOWSHIP MATCH (Breast Match)

APPLICANT AGREEMENT

The Breast Surgical Oncology Fellowship Match (Breast Match) is overseen and supervised by the Breast Surgical Oncology (BSO) Training Committee. By registering in the Breast Match for fellowship positions that start training in the 2026-2027 academic year, I agree to:

1. Abide by all BSO Training Committee Policies posted on the [SSO website](#) pertaining to the Breast Match, including but not limited to the Match Code of Conduct and Professionalism and the Match Program Violation Policy, which are incorporated by reference in and are an integral part of this Agreement.
2. Abide by the Schedule of Dates and Rules of the Breast Match posted on the Breast Match website (natmatch.com/ssobreast), which are incorporated by reference in and are an integral part of this Agreement.
3. Provide complete and accurate information to the Breast Match and to the programs to which I apply. I must apply to programs prior to the application deadline established by each program. All applications I submit to programs participating in the Breast Match prior to the release of the Match results must be sent through the Breast Match Application Service.
4. Not make any commitment to or contract with any participating program prior to the release of the Breast Match results. If I choose to accept a position at a program that is not participating in the Breast Match or decide not to participate in Breast Match for any other reason, then I will not submit a Rank Order List and will submit a withdrawal from the Breast Match prior to the Rank Order List deadline.
5. Accept appointment to the program with which I am matched. The program I match with will send a letter of confirmation of the Breast Match result to me no later than 10 working days after release of the Breast Match results, which I must sign and return to the program within 30 days of the release of the Breast Match results. The Breast Match result constitutes a binding obligation between me and the program. I cannot avoid accepting appointment to the program with which I have been matched, nor may I accept another fellowship position, without a written release from the BSO Training Committee. Furthermore, even if I am released from my Match obligation, I may be subject to legal action by the program and/or disciplinary action by the BSO Training Committee if I do not attend the program with which I have been matched.
6. Pay National Matching Services Inc. (NMS) a non-refundable, non-transferable fee of \$325 USD to register for the Breast Match. The registration fee also pays for up to 15 applications submitted to programs for positions beginning in 2026 using the Breast Match Application Service. If I intend to submit more than 15 applications, I will purchase additional, non-refundable, non-transferable application credits at an additional cost of \$30 USD per credit.

I may express a high level of interest in a program and I may freely discuss any matter with a program that does not include ranking information. I may voluntarily inform a program as to whether or not I intend to rank the program, and a program may voluntarily inform me as to whether or not it intends to rank me. However, neither party (applicant or program) may solicit such ranking information from the other party. In addition, neither party may disclose to the other party or solicit from the other party any information regarding the positioning of any program or applicant on a Rank Order List prior to the release of the Match results. Furthermore, any expression of interest or intention to rank made during the discussion between me and a program is subject to change based on further considerations. Both the program and I have the right to change our Rank Order Lists at any time prior to the Rank Order List deadline.

The Rank Order List I submit for the Breast Match is the sole determinant of my order of preference for programs participating in the Breast Match. Similarly, the Rank Order List submitted by each program is the sole determinant of the program's order of preference for applicants participating in the Breast Match.

I agree that information concerning my participation in the Breast Match may be reported to programs participating in the Breast Match, to SSO, and to other parties deemed appropriate by the BSO Training Committee. Examples of this information include, but are not limited to: my contact information, application information, Breast Match participation status, and Breast Match result.

I agree to accept the Terms of Use and Privacy Policies of the Match websites, as shown at natmatch.com/ssobreast. I agree that NMS may contact me by email and/or phone regarding my participation in the Breast Match.

My appointment to the program to which I am matched may be contingent on my satisfying eligibility requirements for appointment specified by the program and institution.

I understand that the BSO Training Committee has the authority to enforce this Agreement. If I violate any of the terms of this Agreement or the Breast Match Rules or Policies, such as refusing to accept a position at the program with which I have been matched, the violation will be reported to the BSO Training Committee and the BSO Training Committee may impose penalties on me, including barring me from participating in the Breast Match in the future.
